

**Harvest Hosts Quartzsite 2026 Giveaway**  
**OFFICIAL RULES**

HOW TO ENTER: Beginning on January 17, 2026 at 09:00am MST through January 25, 2026 at 02:59pm MST, log on to <https://harveshosts.com/pages/quartzsite-2026> or the Harvest Hosts 2026 Quartzsite Giveaway (“Sweepstakes”) and follow the on-screen entry instructions. Fill in all required information. You may enter only once. Use of any robotic, automatic, programmed, or similar entry method or entering more than the number of times permitted will void all entries and result in disqualification. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. All Twitter, Inc.
